Engages youth and adult participants in free educational canyon tours, clean-up and restoration events throughout San Diego. In 2015-16 SDCL facilitated 1,540 youth participants and 2,118 adult participants, with 766 of these being repeat volunteers. San Diego Canyonlands generated 13,362 volunteer hours during this fiscal year.
