"Property Owners" means owners of the property where the Event takes place.

I understand that during my participation in this San Diego Canyonlands, Inc. Event, I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in each Event and cannot be eliminated without destroying the unique character of the Event. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and possible fatality ("Injuries and Damages") from exposure to the hazards of travel and the outdoors. San Diego Canyonlands, Inc. has not tried to contradict or minimize my understanding of these risks. I know that Injuries and Damages can occur by natural causes or activities of other persons, animals, event participants, leaders, assistants or third parties, either as a result of negligence or because of other reasons. I understand that risks of such Injuries and Damages exist and I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards. I further understand that on this Event there may not be rescue or medical facilities or expertise necessary to deal with the Injuries and Damages to which I may be exposed.

In consideration for my acceptance as a participant on this Event, and the services and amenities to be provided by San Diego Canyonlands, Inc. in connection with the Event, I confirm my understanding that:

- I have read and/or listened to any rules and conditions applicable to the Event; and I acknowledge my participation is at the discretion of the Event leader.
- The Event officially begins and ends at the location(s) designated by San Diego Canyonlands, Inc.. The Event does not include carpooling, transportation, or transit to and from the Event, and I am personally responsible for all risks associated with this travel. This does not apply to transportation provided by the San Diego Canyonlands, Inc. during the Event.
- If I decide to leave early and not complete the Event as planned or decide to continue without the leader, I assume all risks inherent in my decision to leave or continue and waive all liability against San Diego Canyonlands, Inc. and Property Owners arising from that decision.
- This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
- To the fullest extent allowed by law, I agree to **WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY** San Diego Canyonlands, Inc., and any Property Owners, their officers, directors, employees, agents, volunteers and leaders from **any and all liability** on account of, or in any way resulting from Injuries and damages, even if caused by **negligence** of San Diego Canyonlands, Inc. or Property Owners their officers, directors, employees, agents, and leaders, in any way connected with this Event. I further agree to **HOLD HARMLESS** San Diego Canyonlands, Inc., the Property Owners, their officers, directors, employees, agents, and leaders from any claims, damages, injuries or losses caused by my own negligence while a participant on the Event. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns, and includes any minors accompanying me on the Event.
- I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and Damages and notwithstanding such risks, I agree to participate in the Event.
